This appliance may be installed in an aftermarket, permanently located, manufactured home (USA only) or mobile home, where not prohibited by local codes. This appliance is only for use with the types of gas indicated on the rating plate. A conversion kit is supplied with the appliance.

IMPORTANT SAFETY INSTRUCTIONS

WARNING: Improper installation, adjustment, alteration, services or maintenance can cause serious injury or property damage. Refer to this manual.

SAVE THESE INSTRUCTIONS

Make yourself fully aware of all the following instructions and the many features of the Bellfires direct vent gas fireplace appliance.

INSTALLER: Leave this manual with the appliance. CONSUMER: Retain this manual for future reference.

 This appliance reaches high temperatures. Keep children and adults away from hot surfaces to avoid burns or clothing ignition. The appliance will remain hot for a time after shutdown. Allow surfaces to cool before touching.



- 2. Young children MUST be carefully supervised when they are in the same room as the appliance. Toddlers, young children and others may be susceptible to accidental contact burns. The remote control handset should be kept out of reach of children. A physical barrier is recommended if there are at risk individuals in the house. To restrict access to a fireplace or stove, install an adjustable safety gate to keep toddlers, young children and other at risk individuals out of the room and away from hot surfaces.
- 3. Keep the area around your appliance clear of combustible materials, gasoline and other flammable vapor and liquids.
- 4. Do not place embers, vermiculite granules or wood logs against the pilot light burner. Make sure that the pilot flame can burn at all times freely over the main burner. Only in this way is proper ignition of the main burner ensured. Ignoring these directions could lead to a dangerous situation.
- 5. Never place anything on top of the appliance.

IMPORTANT SAFETY INSTRUCTIONS

- 6. Do not use this appliance to cook food or burn paper or other objects.
- 7. Do not use any solid or liquid fuels in this appliance. Use only the gas type indicated on the rating plate.
- 8. This appliance is only for use with the type of gas indicated on the rating plate. This appliance is convertible for use with other gases. A conversion kit is supplied with this appliance.

WARNING: The conversion kit shall be installed by a qualified service agency in accordance with the manufacturer's instructions and all applicable codes and requirements of the authority having jurisdiction. If the information in these instructions is not followed exactly, a fire, explosion or production of carbon monoxide may result causing property damage, personal injury or loss of life. The qualified service agency is responsible for the proper installation of this kit. The installation is not proper and complete until the operation of the converted appliance, is checked as specified in the manufacturer's instruction supplied with this kit.

- 9. This appliance must not be connected to a chimney flue serving a separate solid-fuel burning appliance.
- 10. Installation and service must be performed by a qualified installer, service agency or gas supplier.
- 11. DO NOT operate the appliance with glass removed, cracked or broken.
- 12. DO NOT use abrasive cleaners on the panels. DO NOT attempt to clean the glass when it is hot.
- 13. DO NOT strike or slam the glass panel.
- 14. DO NOT modify the appliance under any circumstances. Any parts removed for servicing must be replaced prior to operating the appliance.
- 15. Turn the appliance off and let cool before servicing, installing or repairing.

 ONLY a qualified service person should install, service or repair the appliance.

 Have burner system inspected annually by a qualified service person.
- 16. Keep control compartments, burners and circulating air passages clean. More frequent cleaning may be needed due to excessive lint and dust. Turn off the gas valve and appliance (OFF on remote control) before cleaning the appliance.
- 17. The venting system MUST checked annually by a qualified service person. If needed, have the venting system cleaned or repaired.
- 18. When the appliance is installed directly on carpeting, tile or other combustible material, it must be set on a metal panel or hearth pad extending at least the full width and depth of the appliance.
- 19. DO NOT obstruct the flow of combustion and ventilation air in any way. Provide adequate clearances around air openings into the combustion chamber along with adequate accessibility clearance for servicing and proper operation.

IMPORTANT SAFETY INSTRUCTIONS

- 20. DO NOT use the appliance if any part has been exposed to or has been under water. Immediately call a qualified service technician to inspect the appliance and replace any part of the control system and any gas control which has been submerged in water.
- 21. DO NOT operate the appliance if any log is broken.
- 22. The installation must conform with local codes or, in the absence of local codes, with the National Fuel Gas Code, ANSI Z223.1/NFPA 54, or the Natural Gas and Propane Installation Code, CSA B149.1.
- 23. This appliance, when installed, must be electrically grounded in accordance with local codes or in the absence of local codes, with the *National Electrical Code*, *ANSI/NFPA 70*, or the *Canadian Electrical Code*, *CSA C22.1*.
- 24. The appliance is equipped with a safety system, whereby the door will extract any over-pressure in a controlled way. In this, the door will briefly open. A safety strip limits the maximum degree to which te door can be tilted. To avoid any possible personal harm when the door opens due to an over-pressure, always maintain a minimum distance of 8 inch (20 cm) to the appliance, when igniting and when burning. If an over-pressure situation occurs, the appliance should be thorougly checked by the installer.

WARNING: Never connect unit to private (non-utility) gas wells. This gas is commonly known as well-headed gas.

CODE APPROVAL

Direct Vent type appliances draw all combustion air from outside of the dwelling through the vent pipe.

These appliances have been tested by CSA and found to comply with the established standards for VENTED GAS FIREPLACES in the USA and Canada as follows:

A manufactured home (USA only) or mobile home OEM installation must conform with the *Manufactured Home Construction and Safety Standard, Title 24 CFR, Part 3280*, or when such a standard is not applicable, the *Standard for Manufactured Home installations, ANSI/NCSBCS A225.1*, or *Standard for Gas Equipped Recreational Vehicles and Mobile Housing, CSA Z240.4*.

WARNING: Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.

GENERAL

This 'direct vent' gas appliance must be installed by a qualified installer in accordance with local building codes, or in the absence of local codes, with the current CAN/CSA-B149.1 or .2 Installation Code (in Canada) or the current National Fuel Gas Code Z223.1-NFPA 54 when installed in the United States.

This appliance, when installed, must be electrically connected and grounded in accordance with local codes, or in the absence of local codes, with the current CSA C22.1 Canadian Electrical Code or with the National Electrical Code; ANSI/NFPA 70 when installed in the United States. If you have any queries regarding the installation, please consult your local gas company.

IMPORTANT:

Before beginning the installation, check that the details on the rating plate correspond to the gas type and pressure to which the appliance will be connected.

The appliance is supplied with a "Centre Fire" double burner. This burner has a specific flame image which is defined by the perforation pattern in the burner cover. See Chapter "DIAGRAM ELECTRICITY AND GAS" and the Operating Manual.

The appliance is factory set to the correct nominal heat input. The pilot light is set to the correct level of consumption.

The appliance will be delivered from the factory with a or 5"-8" concentric connection for extracting the flue gases and supply of combustion air.

It is possible to install the appliance with either a wall or roof outlet. The roof connection must be carried out using a reducer (5" - 8" \rightarrow 4" - 65%") and the concentric flue system 4" - 65%". The fumes are exhausted naturally to the outside environment through the inner 4" pipe whereas the combustion air supply passes between the 4" and 65%" pipes.

The wall connection must be carried out using the concentric flue system 5" - 8". The flue gases are evacuated outside by means of natural draft through the internal pipe of 5", whereas the combustion air is supplied between the pipes of Ø5" and Ø8".

The appliance can be installed in a completely sealed or mechanically ventilated house without extra ventilation and/or fume extraction.

The appliance can be installed as an insert into an existing open fire place or as a builtin appliance in a new fire place. In order to prevent the fireplace heating up excessively, it must be properly ventilated by installing vents at the top and bottom of the fireplace.

A barrier safety screen designed to reduce the risk of burns from the hot viewing glass shall be installed.

The appliance can be fitted with a convection package as an optional extra. This is a "convection jacket" (convection casing) for around and above the appliance, two flexible aluminium pipes and two built-in convection vents. This enables hot air to be circulated into the room.

If required, two additional convector grills can be fitted (= 1x extra convection set). If an existing chimney is to be used, please consult your installer first. If the chimney was previously used for a wood or coal fire, then it should be cleaned by an expert.

CONCENTRIC FLUE SYSTEMS 4" - 6%" and 5" - 8"

DuraVent - DirectVent Pro

The appliance, in combination with the concentric flue system [4" - 6%"] and/or [5"-8"] (rigid and/or flexible) for the brand, DuraVent (DirectVent Pro), has been approved in accordance with the Canadian CSA standard for direct vented gas appliances and may therefore be used only with these systems.

The permitted components for these systems are listed in Chapter "Vent Installation".

The guarantee on the appliance lapses if it is installed, fully or partially, with other components or a different flue system.

The concentric flue [4" - 6%"] and [5"- 8"] systems can be used with either a newly-built or existing chimney.

WARNING: Follow these instructions carefully to ensure safe installation. Failure to follow instructions exactly can create a fire hazard.

The appliance must be installed on a non-combustible floor. If installed on, for example, carpet or vinyl flooring, the appliance shall be placed on a plate of non-combustible material extending the full width and depth of the appliance.

All clearances to combustible and non-combustible materials must be maintained as described in this manual.

Clearances are in accordance with local installation codes and the requirements of the gas supplier.

Never use combustible materials during the installation.

During installation of the appliance, a clearance of 0.12 in (3 mm) should be maintained on all sides of the appliance to allow for expansion of the appliance during operation.

Do not insulate the appliance! Only the top and sides may be fitted with a strip of white, loose insulation wool (heat-resistant to 1832°F (1000°C)), width 5.9 in (15 cm) max. to protect the wall.

Do not use fibreglass or Rockwool, or any other sort of insulating material. These emit a pungent odour. This is considered extremely unpleasant. They may also cause discolouring of the column.

Combustible materials, such as curtains, should not be placed in the vicinity of the appliance. Minimum safe distance: 40 in.

Never place the appliance directly to a combustible or non-combustible rear wall and side wall.

Clearances to combustible material




Figure 1: Clearances to combustible material

Always place a non-combustible insulation plate with a thickness of min. 1" (2.54 cm) between the appliance and the rear wall and the side wall according to figure 1. Minimum clearances to combustible material must be maintained.

Clearance to combustible ceiling: Place a non-combustible insulation plate with a thickness of min. 1¼" (30 cm) at a height of minimum 20" above the appliance. Maintain a free space of 4" (10 cm) between the insulation plate and a combustible ceiling.

Clearance to non-combustible material

Always place a non-combustible insulation plate, at least $\frac{1}{2}$ " (12 mm) thick between the appliance and a non-combustible rear and side wall. Maintain a free space of at least $\frac{3}{4}$ " (2 cm) on either side of the insulation plate.




Figure 2: Clearances to non-combustible material

Minimum clearances as shown in figure 2 must be maintained.

Ventilation

Ventilate the fireplace/chimney breast:

- all spaces between the appliance and the insulation plates
- all spaces between the insulation plates an all surrounding walls by allowing vents above and below.

Insulation plate/board

Any used insulation plates must have a maximum thermal conductivity of 0.69 BTU/ (ft².h.°F/in) (0.10 W/m.K). Suitable insulation materials are listed in table 1.

Do not use fibreglass or Rockwool, or similar material. These materials emit a pungent odour, which is considered extremely unpleasant.

Mantel clearances




Figure 3: Mantel clearances

Any mantel piece made of combustible material should be placed at least 2" from the side and top of the fireplace opening. Minimum mantel clearances are shown in figure 3 to 5.




Figure 4: Top mantel clearances


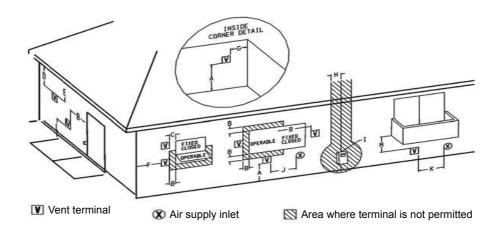


Figure 5: Side mantel clearances

There are two basic types of direct-vent installation:

- Horizontal termination
- Vertical termination





Figure 6: Vertical roof-mounted outlet without bend

The combined flue gas channel and combustion air intake requires one of concentric flue system configurations as depicted in figures 6 to 11.

CONCENTRIC FLUE SYSTEM

IMPORTANT:

- Due to the high temperature of the outer walls (approx. 150°C), no flammable materials may be located or used in the vicinity of the flue system.
 The complete flue system, must therefore be sleeved with a heat resistant material after assembly.
- Ventilate the covered concentric flue by fitting a grid near the floor and ceiling (on each floor).
- Do not insulate the concentric flue.

Appliance: Concentric flue connection Ø5" - Ø8"





Figure 8: Vertical chimney outlet using an existing lined chimney (Flexible Ø4" and/or rigid Ø4" / Ø6 %")




Figure 10: Horizontal wall termination




Figure 11: Horizontal wall termination

IMPORTANT:

- The appliance must be constructed on a sufficiently solid floor that can bear the weight of the appliance.
- Ensure a free space of at least 0.4 in (1 cm) between the bottom of the appliance and the floor.
- Ensure that the temperature of the floor under and in front of the appliance can never rise above 185 °F (85°C)! Make use of a temperature protection plate (of noncombustible material) on the floor if necessary.
- Take care with a floor made of a combustible material.
- Refer for the minimum clearances to (non)combustible material to the "clearances" chapter elsewhere in this manual.
- Never position the appliance directly against the rear wall, but always in accordance with the installation instructions in chapter; CLEARANCES. Use only the specified insulation plates!
- Never use combustible materials during the installation.
- Ventilate the fireplace, by allowing vents above and below the fireplace.
- During installation of the appliance, a clearance of 0.12" (3 mm) should be maintained on all sides of the appliance to allow for expansion of the appliance during operation.
- Do not insulate the appliance! Only the top and sides may be fitted with a strip of white, loose insulation wool (heat-resistant to 1832°F (1 000°C)), width 6" (15 cm) max. to protect the wall.
- Do not use fibreglass or Rockwool, or any other sort of insulating material. These emit a pungent odour. This is considered extremely unpleasant. They may also cause discolouring of the column.
- Flammable materials, such as curtains, should not be placed in the vicinity of the appliance. Minimum safe distance: 40" (100 cm).

If desired, fit a convection package to the appliance. (See pre-installation instructions)



The appliance can be easily installed using a set of carrying brackets (accessory). After installing: remove carrying brackets!




Figure 12: Appliance installed in ventilated chimney breast




Figure 13: Appliance installed in ventilated chimney breast

When fitting the appliance, it can be levelled with the adjustable feet. These adjustable feet can be reached via the openings (4x), after removing the protective covers, in the corners of the floor of the combustion chamber.

The floor of the combustion chamber can be reached after the window and the grill around the burner have been removed (see Chapter: "DISMANTLING / ASSEMBLING OF THE GLASS").

Using an Allen key (no. 5), the appliance can be adjusted to the required height.

IMPORTANT:

Press the 4 protecting covers back into the floor.



- Position the gas supply pipe such that it can be easily mounted after installation.
 Because the control system is outside the appliance, the gas pipe must lead to where
 the operating unit (built in), the gas regulator block (and the receiver) assembly are
 fitted.
- Position the appliance in accordance with the installation instructions in chapter; CLEARANCES. Use only the specified insulation plates.
- Attach the appliance to the rear wall with 2 wedge bolts. Use the adjustable mounting brackets at the side of the appliance for this.

WARNING:

Connection of the appliance to gas supply must be performed by a qualified installer, service agency or the gas supplier. Follow the local codes.

IMPORTANT:

During gas connection, take care not to twist the gas regulator block. Make sure that both the gas regulator block and the supply pipes are not subjected to stresses.

GAS LINE INSTALLATION

The appliance is supplied with a built-in operating unit.

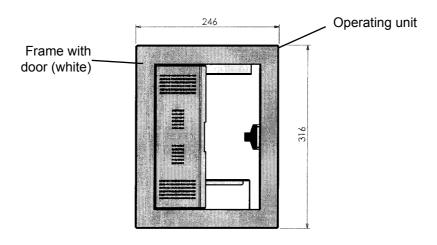


Figure 14: Operating unit

Remove the decorative edging and door of the operating unit. Fit the separate operating unit, where the gas regulator block and receiver will be placed, on max. 20" (50 cm) from the appliance.

The burner, gas regulator block and receiver have been fully factory assembled.

Disconnect the bracket with the gas regulator block and receiver from the appliance. Carefully move the bracket with the gas regulator block, receiver, pipes and cables to the operating unit. Mount the bracket at the bottom of the operating unit.

IMPORTANT:

Take care that no pipes get damaged and no compression fittings come loose when moving the gas regulator block. Prevent twisting the flexible pipes! Check all compression fittings for leaks afterwards!

GAS LINE INSTALLATION

Mount the receiver in the top of the operating unit. Check afterwards that all electric connections are properly connected.

Route all piping and cables from the operating unit to the appliance through an easily accessible hollow cavity.

During subsequent installation of the operating unit, protect the gas regulator block and piping against encasement by cement etc.

The gas line connection can be made using ½" rigid tubing or an approved flex connector. Since some municipalities have additional local codes it is always best to consult your local authorities and the current edition of the National Fuel Gas Code ANSI.Z223.1, NFPA54. In Canada CSA-B149 (1 or 2) Installation Code.

A CSA design-certified equipment shutoff valve must be installed upstream of the appliance. Contact your dealer for the purchase of CSA design-certified equipment shutoff valve. The gas regulator block is equipped with a screw type pressure test point (inlet pressure tap in figure 17). Therefore it is not necessary to provide a ½" test point up stream of the control.

The CSA design-certified shutoff valve (main gas valve) must be installed in an accessible location. This main gas valve is used for opening or closing off the gasflow to the appliance.

IMPORTANT:

Cement and chalk can damage the piping and can, in turn, lead to gas leaks.

Disassembly and assembly of pipes and cables:

If necessary for mounting, all pipe compression fittings and cable connectors can be temporarily disassembled. After mounting, carefully reassemble all pipes and cables. Check afterwards all compression fittings for leaks and that all electric connections are properly connected.

IMPORTANT:

Screw the thermocouple connection (and thermocouple interrupter) manually into the gas regulator block. Afterwards, carefully fasten a half turn with a spanner.

GAS LINE INSTALLATION

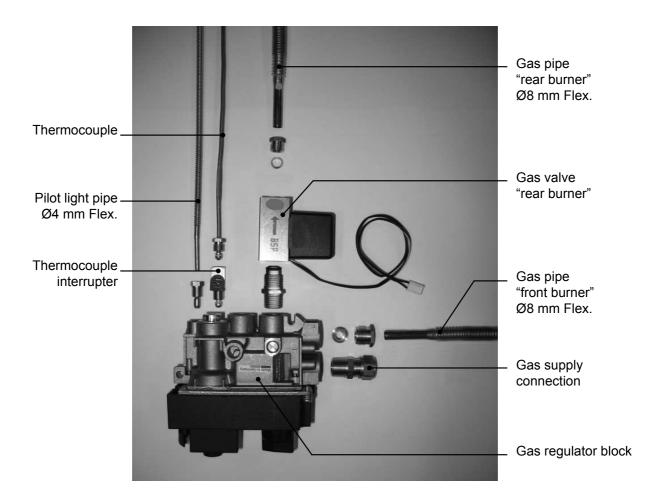


Figure 15: Gas regulator block and gas valve: Gas and thermocouple connections

Note: Check that the flexible burner pipes are correctly connected! The gas connection of the gas valve "rear burner" must be connected to the "rear burner"! See figure 15 and Chapter; DIAGRAM ELECTRICITY AND GAS.

Switching over the flexible burner pipes during assembly can lead to an explosive ignition. Prevent this at all costs!

The appliance must not be subjected to any test pressures exceeding $\frac{1}{2}$ psi (= 3.45 kPa = 34.5 mbar). Isolate or disconnect this and any other gas appliance control from the gas line when pressure testing.

After connection of the gas supply, check that all connections are completely gas tight using soapy water (mixture of 50/50 water and soap solution) or a leak tester.

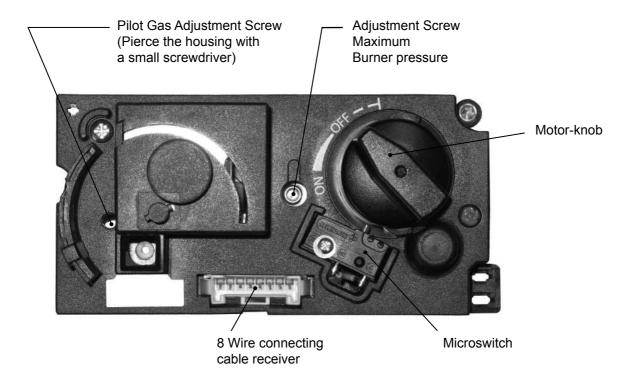


Figure 16: Gas regulator block - Front

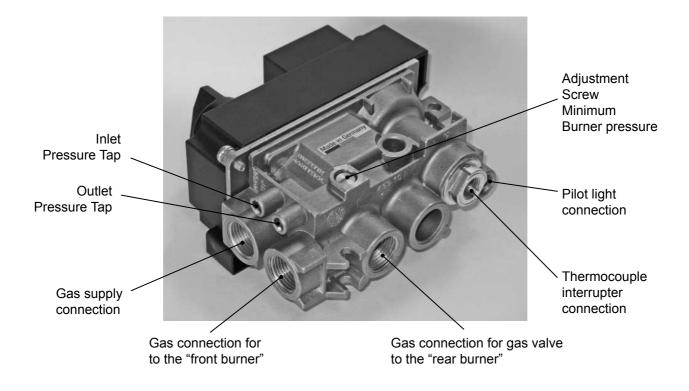


Figure 17: Gas regulator block - Rear

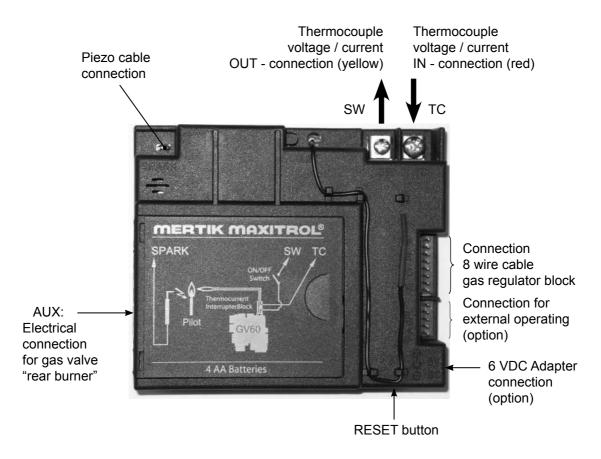


Figure 18: Receiver - Top

BUILDING IN THE APPLIANCE

Remove the front of the casing, if applicable. (See Chapter: DISMANTLING / ASSEMBLING OF THE GLASS.)

Decide on positions of the vents (grilles above and below the fireplace) and, if applicable, the hot air grids of the convection package.

The brickwork must be built up around the hearth. In connection with the hearth expanding during burning: there must be at least 0.12" (3 mm) clearance on either side of the appliance. Do not build up the brickwork farther than the angle irons/brackets (keep in mind the thickness of any plastering!).

IMPORTANT:

Do not use masking tape on the appliance when installing and plastering. Tape can damage the finish of the hearth.

Connect up the convection package, if applicable.

The optional mantle iron is intended for supporting the brickwork above the hearth. The mantle iron must rest on the brickwork on both sides so that upward building is possible. The brickwork therefore must not rest on the fireplace; there must be approx. 0.12" (3 mm) clearance in connection with the weight.

If using other materials, such as stone or heat-resistant plating, you should follow the supplier's instructions.

Once the fireplace has been finished, you can now, fit the frame with the small door to the operating unit.

After installation in a new fireplace and/or applying new cement work, the appliance cannot be used for at least four weeks.

IMPORTANT:

- Carefully place the chips of wood/embers/vermiculite granules and log set, on and around the main burner according to the directions in this chapter.
- Do not place any chips of wood/embers/vermiculite granules or log set against the pilot light burner. For that reason, the main burner has a protective pilot-light cowl. Never remove this cowl! Make sure that the pilot flame can burn at all times freely over the main burner. Only in this way is proper ignition of the main burner ensured. Ignoring these directions could lead to a dangerous situation.
- Make sure that all burner orifices remains free at all times!
- The burner bed (with chips of wood/embers/vermiculite granules) and the positioning of the logs must not be changed.
- Only use those items supplied! These been rigorously checked and the quantities adapted to the appliance.
- Replacement parts, including the ceramic mat are available from your dealer.
- Fitting may only be carried out by a qualified person.

Remove the glass according to the instructions in Chapter: DISMANTLING / ASSEMBLING OF THE GLASS.

This section only applies for appliances delivered with a ceramic log set.

WARNING: Make sure that all burner openings remain free!!
Burner orifices, which are not open, could lead to a dangerous situation.

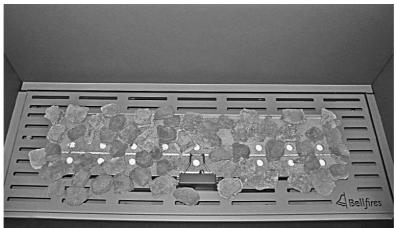
Ceramic log set + embers + vermiculite granules

- Place the ceramic mat on the burner in such a way that the holes in the mat are in line with the burner openings. (Note: The ceramic mat is already placed on the burner when delivered from the factory.)
- 2. Remove the embers carefully from their packaging and spread them evenly over the burner mat and the grate around the burner. DO NOT COVER BURNER OPENINGS!
- Remove the black vermiculite granules from their packaging and distribute the vermiculite granules (50 gram) evenly over the burner. DO NOT COVER BURNER OPENINGS!

WARNING: Embers and vermiculite granules should not block the large burner openings (Centre fire burner - 0.62 in (16 mm). Embers and vermiculite must not be placed next to the pilot light burner.





MOUNTING OF FLUE GAS RESTRICTION PLATE

Depending on the length and shape of the concentric flue system and the chimney construction, you should, if indicated, fit a restriction plate with a certain width (B) into the ceiling of the combustion chamber.

To do this, see the set-up options as listed in figure 6 through 11.


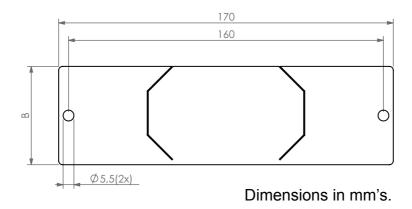


Figure 22: Positioning restriction plate

The following restriction plates are supplied:



Restriction plate:	Concentric flue connection appliance [Ø5" - Ø8"] (Roof terminal)
Width:	B = 40 mm

The size of each plate (in mm's) is printed on the plates.

After installation, visually check the gas flame. When the fire is ignited, the flames should be short and blue/yellow in colour. These flames should gradually increase in height and become more yellow. When all flames are yellow, the gas fire has reached the correct temperature.

THE GAS FIRE IS NOW READY FOR USE

ANNUAL MAINTENANCE

IMPORTANT:

It is essential that the appliance, the complete concentric flue system (where possible) and the outlet are cleaned and inspected annually by a recognised fitter/gas specialist. The safe operation of the appliance will thus remain guaranteed.

Maintenance consists of the following:

- Remove first the embers, vermiculite granules and logs set from the main burner and carefully clean these with a soft brush.
- Clean and inspect (visually) the main burner, pilot light, combustion chamber, flue system and combustion air intake. Dust can be removed using a vacuum cleaner.
- Clean the glass on the inside of the appliance with glass spray or ceramic hob
 cleaner. This also applies to the black mirror rear wall and side panels, if the
 appliance is fitted with these.
- After cleaning; Carefully replace the embers, vermiculite granules and logs set on and around the main burner according to the installation directions in this instruction booklet.

Do not place any embers, vermiculite granules or logs against the pilot light burner. Make sure that the pilot flame can burn at all times freely over the main burner. Only in this way is proper ignition of the main burner ensured. Ignoring these directions could lead to a dangerous situation.

- Check the gas supply, flue system, and combustion air supply route for leaks.
- Check the correct operation of the gas regulator block, thermocouple circuit and the ignition of the main burner.
- Check the gas inlet-pressure (both when the appliance is off and when it burns at maximum) and the burner pressure.
- Check the complete concentric flue system including the outlet construction.

 A camera can be used to inspect the whole length of the flue gas outlet and the combustion air intake.

Also check that all connections are secure.

FAULTS

POSSIBLE REASONS

Possible reasons for the gas fire going out are:

- The concentric flue system is not installed according to one of the methods detailed in Vent Installation.
- An incorrect "flue gas restriction plate" is fitted.
- The pilot light extinguishes if fumes are not exhausted or are insufficiently exhausted.
- The pilot light is either dirty or defective.
- · Insufficient gas pressure.
- · (Internal) leak of the concentric flue system.
- Thermocouple voltage is too low. This is usually caused by insufficient heating of the thermocouple by the pilot light.
- Dirty electrical contacts in the thermo-electrical system; for example, the thermocouple connection.
- Batteries in receiver or remote control are flat.

SAFETY MEASURES IN THE APPLIANCE

Thermo-electric pilot light shut off

The appliance is protected by means of a thermo-electric pilot light shut off in the event of a gas escape from the main burner.

Over pressure safety system

The appliance is fitted with a patented safety system, whereby the door will extract any over-pressure that arises in a controlled way. In this, a spring system briefly causes the door to hinge forward a few centimetres. A loud noise can occur.

A safety strip limits the maximum degree to which the door can be tilted.

If an over-pressure situation occurs, the appliance should be thoroughly checked by the installer.

WARNING: Do not operate appliance with the glass front removed, cracked or broken. Replacement of the glass should be done by a licensed or qualified service person.





- With the hook, pull the thin, metal spring strips on the top left and right from the studs on the frame.

Note!:



When loosening the frame and after it has been loosened, support it with your hand to prevent it falling forward!







- Place paperboard on the chimney breast, under the frame. This helps prevent damage.



- Dismantle the safety strip from the frame.



- Carefully tilt the frame and the window forwards.

Note!: Frame and window are two separate parts!



 Take hold of the frame and the glass clamped together and pull these upwards.



- Frame and glass are now removed from the appliance.

Assembling of the glass:

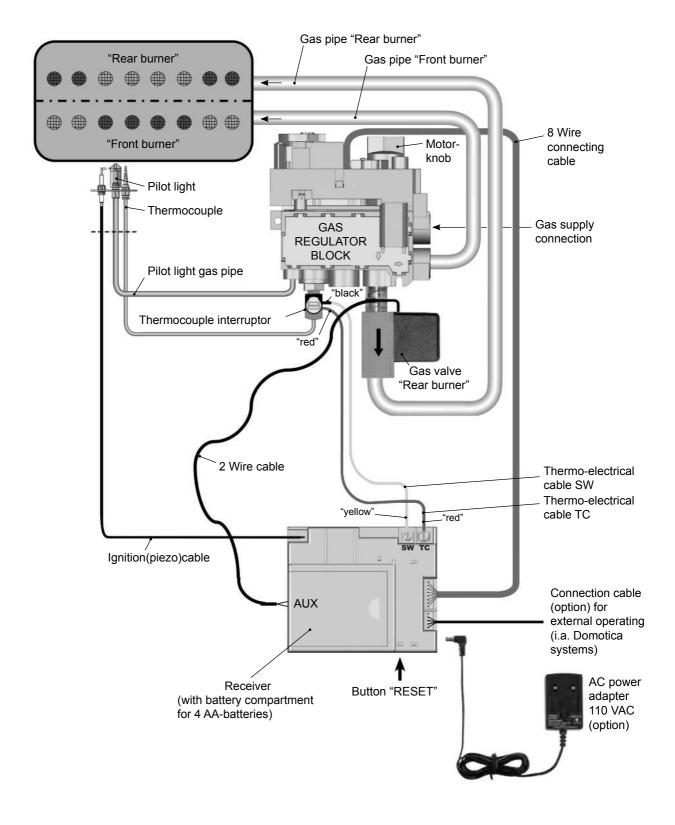
The assembly of the glass takes place in reverse order.

Important:

- Check whether the frame is properly positioned underneath in the 2 holes of the front.
- Check whether the frame is placed in the middle of the front.
- Check whether the safety strip is securely fastened to the top of the frame (middle).
- The glass (frame) must fit tightly all round to the edge of the combustion chamber.
- Check that the spring strips, on the top, remain in their proper place.



The qualified service agency is responsible for the proper installation of this kit.

The installation is not proper and complete until the operation of the converted appliance is checked as specified in the manufacturer's instructions supplied with the kit.

- 2.3. Complaints will only be accepted if they are reported to the Bellfires dealer, together with the serial number of the Bellfires hearth which is stated on the front of the instructions for use.
- 2.4. In addition, the original receipt (invoice, receipt, cash receipt) showing the date of purchase must also be submitted.
- 2.5. Repairs and replacements during the warranty period do not give any entitlement to an extension of the warranty period. After a repair or replacement of warranty parts, the warranty period shall be deemed to have started on the date of purchasing the Bellfires hearth.
- 2.6. If a certain part is eligible for the warranty and the original part is no longer available, Interfocos B.V. shall ensure that an alternative part of at least the same quality shall be provided.

Article 3: Warranty exclusions

- 3.1. The warranty on the Bellfires hearth ceases to be in effect if:
 - a. it is not installed according to the supplied installation instructions, and to national and/or local regulations;
 - b. it has been installed, connected or repaired by a non-Bellfires dealer;
 - c. it has not be used or maintained according to the instructions for use;

- d. it has been changed, neglected or roughly treated;
- e. it has been damaged as a result of external causes (outside the hearth itself), for example, lightning strike, water damage or fire;
- 3.2. In addition, the warranty lapses if the original purchase receipt shows any change, deletion, removal or if it is illegible.

Article 4: Warranty area

4.1. The warranty is only valid in those countries where Bellfires hearths are sold through an official dealer network.

Article 5: Warranty period

- 5.1. This warranty will only be granted during the warranty period.
- 5.2. The body of the Bellfires hearth is guaranteed for a period of 10 years against construction and/or material faults, starting from the moment of purchase.
- 5.3. For other parts of the Bellfires hearth, a similar warranty applies from the moment of purchase for a period of one year.
- 5.4. For user parts such as glass, glass (cord), thermocouple and the interior of the combustion chamber, a similar guarantee is given until after the first burning.

Article 6: Liability

- 6.1. A claim granted by Interfocos B.V. under this warranty does not automatically imply that Interfocos B.V. also accepts liability for any possible damage. The liability of Interfocos B.V. never extends further than that stated in these warranty conditions. Any liability of Interfocos B.V. for consequential damage is expressly excluded.
- 6.2. That stated in this provision is not valid if and to the extent that is derives from a mandatory provision.
- 6.3. All agreements entered into by Interfocos B.V. are, unless specifically stated otherwise in writing and to the extent that they are permitted based on applicable law, subject to the Conditions of the Dutch Metal and Engineering Association (METAALUNIEVOORWAARDEN), as filed with the registrar of the Court of Rotterdam on 1 January 2008.
